2. Directors Report: Patrick Kass

• Vaccine Site opens to the public at the Nick – once the vaccine is received the Nick can take up to 1000 people per day.

Program Updates

- o Continue to work through the budgets and will have more to discuss at the next meeting.
- We are still trying to determine the impacts of the past year and how our operations will look in the fall of 2021.
- The westside of campus is at an occupancy rate of 70%; visitor revenue is down at Lot 75 due to limited visitors at the hospital.
- o Central campus is at 20% occupancy.
- o We will continue to be flexible with our programs.
- Visitor parking on campus is down considerably since we are not holding events on campus.
- We need to understand how telecommuting is going effect our operations and how we adjust going forward.

Frances Street Update

- o Continuing with the planning study and working on the conceptual layouts and costs.
- Construction could possibly begin in the 2023-2025 biennial.

• Commuter Solutions Update: Dar Ward

- Campus Bus
 - After working through the data from this fall to identify bus ridership trends; adjustment will be made for the spring semester. Do not want to waste resources.
- Bicycle Maintenance Classes
 - Virtual class will start up for the spring semester and go through June 2021.
 - Carolyn has been doing a great job at promoting the classes and posters will go up in bus shelter soon.
- Survey coming out soon about the products offered by Transportation Services during the pandemic. [Patrick Kass]
